- How to obtain access to ASYCUDA World
 - VPN Application

To be connected to the Customs Network through the Firewall via the Internet the Traders need to Obtain a Virtual Private Network Electronic Certificate from the ICT Division of Sri Lanka Customs.

DTI Application

Direct Trader Input facility is provided by the Customs Administration to submit Customs Declarations electronically directly to the Customs System through the Internet by the Trader or his Agent(Declarant) being at their premises. For this purpose an Asycuda Username & a Password should be obtained by the ICT Division.

How to become a Customs House Agent



REQUIREMENTS TO BE FULFILLED BY THE APPLICANT

- 1. Applicant should have a pass in G.C.E. Ordinary Level Examination at least with 6 subjects including Sinhala/Tamil Language, Mathematics and English.
- 2. The applicant has to submit a "Letter of Request" from the employer to follow the CHA/WA Course.
- 3. Application should be submitted with the original documents for verification and also with copy documents as given below.
 - i. A photocopy of the G.C.E. Ordinary Level Certificate issued by the Examination Department of Sri Lanka.
 - ii. A photocopy of the National Identity Card.
 - iii. A photocopy of the T- Pass (If applicable)
